**Health Department:** Susan Long presented the yearly report. Out of 114 counties Osage County was ranked 13<sup>th</sup>, but with community outreach and staff efforts Osage County is now ranked number 4 out of 114. Commissioners sent the congratulations to the Health Department Staff. Osage County will participate in the new shingles vaccine. Susan Long has order 50-60 does that is expected to make its arrival sometime in February. Susan Long said that it is a two dose vaccine and is supposed to be 85-90% better than the original vaccine. Anyone over the age of 50 should get the vaccine. If you've had shingles in the past, you need to wait

6 months before getting the shot since you are still susceptible to getting shingles again. Susan stated that she is possibly going to be out for roughly 2 months due to a knee replacement.
